City Council Meeting January 10, 2011

The City Council met in regular session at 6:00 PM at City Hall with the following members present: Mayor Zimmer and Council: Sitzler, Brandriet, Forward, and Kuipers. Harris arrived at 6:10 PM and Rosendahl was absent. Visitors present: Stacy Zimmer, Darwin Gebhardt, Jerry Hollingsworth, Audrey O'Brien, Jon Hansen, Bill Geffre, Robert Lindberg-Northern Excavating, Jerod Klabunde-Moore Engineering, and Kent Ritterman-Moore Engineering. Employees present: Gary Neuharth, Pat Nelson, Marke Roberts, Corey Heim and April Haring.

<u>Minutes and Auditor Reports</u>: Forward moved, Kuipers second to approve minutes and all other reports as presented, carried.

New Business:

First Reading Sales Tax Request, Irrigation Days and 125th Planning Committee applied for \$3,500 in funding for the June 2011 Irrigation Days and 125th Celebration. Funding will help pay for the advertising and games during the event.

Visitors:

Jerry Hollingsworth asked the Council to consider requesting Waste Management to allow businesses to recycle under the City's contract. It will be reviewed but initially Waste Management did not allow businesses in the City's contract due to fluctuating amounts in recycling. They have agreed to individual contracts with businesses and apartment buildings. The contact information will be forwarded to Jerry to also pursue an individual contract.

Robert Lindberg-Northern Excavating reviewed the time line for the construction project this year at James Valley Grain. He asked the Council to reconsider the amount assessed for liquidated damages. It was noted there will be additional expenses billed to the City for the extra time and work for the project inspector. Harris moved, Forward second to reduce the liquidated damages to \$13,000.00, roll call approved.

East Main Truck Route, Darwin Gebhardt asked if there would be any further discussion regarding the change in the truck route. A meeting is scheduled at the Dickey County Courthouse with the Commissioners on January 18.

Bill Geffre was present upon request to discuss the past due invoice for the demolition of the building at 411 Main Avenue. He explained that he is currently unable to find financing but offered the City his other properties in lieu of payment but also noted they are all mortgaged. He is unsure if he will be able to pay as he still has mixed feelings over what took place. The property in which the building was located has been deeded to the City. It was discussed to continue through assessments and possibly legal action if left unpaid.

Moore Engineering:

2009-2 Phase 1 Water and Sewer Improvements is in the grant phase. The funding remaining must be spent using ARRA regulations and approved by USDA Rural Development. Estimates are being received to grind up the asphalt chunks at the landfill.

2010-1 Phase 2 Water and Sewer Improvements construction is planned to begin as soon as possible this spring. Forward moved, Kuipers to approve change order to add water extension on 16th Street between Main Avenue and Hickory Avenue with an estimated cost of \$20,000, carried.

Additional Paving, a public informational meeting will be scheduled for property owners along gravel streets and alleys to determine interest in paving these areas.

ND Highway #1 Improvement is projected to be bid in May and completed in the fall. NDDOT will have a memorandum of agreement for the City to sign shortly.

Safe Routes to School Project plans and specifications were reviewed. Sitzler moved, Brandriet second to approve the plans and to send a notice to affected businesses and land owners to address any questions or concerns, carried. The project will be constructed this summer.

Flooding, Darwin Gebhardt brought up concerns of diversion plans as explained to him by Gary White, Dickey County Commissioner. Meetings will be held with all entities involved prior to any decisions being made.

<u>Year End Financial Statement</u>: Forward moved, Brandriet second to make following amendments to 2010 Budget: General Fund increase \$1,000.00, Water Fund increase \$3,000.00, Garbage Fund decrease \$8,000.00 showing an overall decrease of 2010 Budget by \$262,202.00, carried.

Sitzler moved, Brandriet second to approve the report as presented showing Year End Financials for 2010 ending cash balance \$4,262,646.19, carried.

<u>Pledge of Assets and Designate Depositories</u>: Starion Financial, First Community Credit Union, First State Bank are designated depositories with pledges of \$4,330,587.21, \$0.00, \$311,592.99 accordingly; Forward moved, Kuipers second to accept report and depositories designation, carried.
