City Council Meeting June 9, 2014

The City Council met at 6:00 PM at Oakes Armory with the following members present: Mayor Zimmer and Council: Sitzler, Strutz, Engel, Forward, Harris and Brandriet. Zoning Hearing:

Sitzler moved, Brandriet second to introduce and approve RESOLUTION TO CHANGE ZONING OF LOTS 3,4,5 BLOCK 35 WASHBURNS FROM RESIDENTIAL TO COMMERCIAL, roll call approved.

Variance Hearing:

The Variance Request for 122 North 11th Street was reviewed. The application is for the construction of an addition to home and garage to be built within the allowed setback. Forward moved, Strutz second to accept the variance request, carried.

Engineer Report

Water Tower Improvement, Bid Opening is scheduled for July 16, 2014, 1PM at City Hall. Harris moved, Engel second to approve Engineering Agreement, carried. Sitzler moved, Harris second to approve engineering invoice to Moore Engineering for \$22,200, carried.

James Valley Grain Sewer Force Main estimates to lower to 9 ½ feet were reviewed; current depth is 7 ½ feet. Alternate option to lowering main is to install an access pit manhole to aid in cleaning out main. Will be reviewed further and discussed at July meeting.

Rosendahl Development-Cline's Addition, Dana Rosendahl addressed concerns of smaller water line installed in recent development. The City Council has concerns of the 6 inch line that was installed instead of the planned 8 inch line. The smaller line is not catastrophic to the system and has little impact on water supply to area. Engel moved, Harris second to allow the 6 inch line to remain; any further development will require an 8 inch line. If in the future the current 6 inch line become inadequate and needs to be replaced, the expense will be assessed to property owners, carried.
