## **Committee Reports:**

**Armory**, Harris reported the bathroom project for the Prairie Twisters is almost complete. **Police**, First Reading of Traffic Ordinances regarding parking and discussion of concerns of unmoved vehicles during snow removal. Fire, Brandriet reported fire department still working on estimates for building improvements. Brandriet moved, Harris second to approve renewal of disability insurance and increase policy to "Plan 1" with three year payment installments, carried. President's Day garbage schedule will remain the normal pickup on Monday since recycling is scheduled for Tuesday, public notices will be given. Street Light Pole Painting, estimate has been received to paint each street light pole along Highway 1 from railroad track to railroad track and those by Alco for \$100 each. Discussion was held on type of paint and method to be used. Nelson will do more research for next meeting. **Armory Roof**, the roof over the classroom is leaking, was advised to stop classroom remodeling project until problem can be fixed which might not be until spring. Brandriet and Nelson will look into possible warranty from when roof was installed and other options for repair. Water, discussion was held regarding the installation of incorrect water lines in Cline's Addition. A letter will be sent by the City Attorney to the developer requesting the six inch water line installed be replaced with the correct size as stated in the plans. Dangerous Building 411 Main Avenue Payment, Forward will contact William Geffre in regards to final outstanding payment and let City Attorney know how to proceed. Attorney Salary, Strutz moved, Forward second to increase salary from \$300 per month to \$500 per month, roll call approved.
