411 Main Avenue Building:

Discussion regarding the status of the building that has been defined as a dangerous building per City Ordinance. Sitzler moved, Brandriet second to accept the bid from Comstock Construction of \$91, 510 for demolition of 411 Main Avenue building and provide protection to 409 Main Avenue, carried. Brandriet moved, Harris second to proceed with demolition based on insurance recommendations and will invoice the costs of demolition and construction to property owners, carried.

Committee Reports:

Water, the water main installed on east Main Avenue will be reviewed to possibly have the line "looped" to improve the water quality. **Garbage**, Brandriet moved, Kuipers second to not allow disposal of trees from non-residents at the City Landfill, carried. **Streets**, Sitzler moved, Kuipers second to remove the truck route on east Main Avenue, carried. The truck routes on 3rd Street and 4th Street will be reviewed. **Cemetery**, Harris reported that Sandy Frojen has started a project to investigate the graves at the cemetery and make sure the names are recorded correctly. **Landfill**, Pat Nelson reported the Department of Health revisited the Landfill and is happy with the corrections and improvements that have been made.

Moore Engineering:

Kent Ritterman and Jerod Klabunde updated the Council on the current projects.

2009-2 Phase 1, Sitzler moved, Kuipers second to accept the following completion dates to begin the one year warranty period: Seeding completed August 15, Concrete completed September 1, and Underground work completed August 1, carried.

Discussed concerns in the times and scheduling and expressed disappointment in delays.

Kuipers moved, Sitzler second to approve Partial Pay Estimate #7 to Kuechle Underground for \$177,372 for construction, carried.

Sitzler moved, Rosendahl second to approve Moore Engineering Invoice for \$43,794.93 for 2009-2 Phase 1, carried.

2010-1 Phase 2, discussions are still being held with the ND Department of Transportation regarding the cost share and plans for Highway 1 construction.

Sitzler moved, Harris second to introduce and approve RESOLUTION TO AWARD CONSTRUCTION BID FOR IMPROVEMENT DISTRICT 2010-1 PHASE 2 TO KVAMSDAL CONSTRUCTION CONTINGENT UPON RURAL DEVELOPMENT APPROVAL AND ND DEPARTMENT OF TRANSPORTATION SCOPE. Roll call: Rosendahl-yes, Brandriet-yes, Kuipers-yes, Forward-yes, Harris-yes, Sitzler-yes, carried.

Rosendahl moved, Brandriet second to approve Moore Engineering Invoice for \$131,100.00 for 2010-1 Phase 2, carried.

2009-2 Phase 1 Part C, Forward moved, Rosendahl second to approve Moore Engineering Invoice for \$4,480, carried.

2010-2 JVG/SDWG, the timeline was discussed. Contractor has asked for extension because of weather and other delays. James Valley Grain and SD Wheat Growers will be contacted regarding their opinion on this request.

Brandriet moved, Sitzler second to approve Partial Pay Estimate #1 to Northern Excavating for \$275,037.57 for construction, carried.

Forward moved, Brandriet second to approve Moore Engineering Invoice for \$31,303.40 for 2010-2, carried.

Unfinished Business:

City Lodging Tax, the benefits and uses of this tax was discussed. Kevin Huffman from the Oakes Parks and Recreation stated the Park Board's support of this revenue to help with upcoming tournaments. More research will be done and topic will be placed on the agenda later in the year. **Landfill**, as Pat Nelson mentioned earlier the ND Department of Health revisited the site and was happy with the outcome. A letter was also sent to the Department of Health outlining the work that was done and planned to be done.

New Business:

Main Avenue, Party on the Pavement poster was handed out to Council and Mayor. Volunteers are being asked to help serve. Forward moved, Kuipers second to pay the Oakes Area Chamber of Commerce \$1,000 from the advertising fund to help with this event, carried.

Reimbursement request was received from Wildrose Floral for repairs completed due to the current construction. Forward moved, Rosendahl second to deny reimbursement for repairs to service line in the building and to have them contact Kuechle Underground, carried. Brandriet moved, Rosendahl second to deny request for reimbursement to frame window wells, carried (Harris voted no).

2nd Reading Sales Tax Request from Charles Forward for Eagle Scout Project. Kuipers moved, Brandriet second to approve sales tax request of \$300, carried.

Propane Bid, Forward moved, Rosendahl second to accept bid for propane from Farmland Co-Op of \$1.39 for the 2010-2011 season, carried.

Dog Behavior Report, letter from the Scheuring's Dog Obedience Instructor was read. According to the letter the dog has met the requirements set by the City Council in March 2010 to remain in town.

Zoning Appointment, Kuipers moved, Brandriet second to approve appointments of Jeff Forward and Bill Schmitz to the Zoning and Planning Commission for a three year term each, carried. **Logo**, Forward moved, Kuipers second to approve and accept new City Logo and Brand, carried.
