Visitors:

Charles Forward requested funding for his upcoming Eagle Scout Project. He plans on revising the Food Pantry by upgrading and updating the space. The project is estimated to cost \$2,250; he is requesting \$300 from the City of Oakes and has plans on requesting funds from other entities. First Reading of Sales Tax Request for this project was approved.

Ron Goodman informed the City Council of a petition being circulated to begin a county library levy. The petition will need 700 signatures to be on the November ballot and will 60% to pass. If and when the levy passes the Council will need to make a decision if they would like the residents to participate or exempt the City from this levy. Currently the City levies an average of 3.5 mills for the library which generates close to \$11,000.00 plus the library also receives funding from the City Sales Tax.

Committee Reports:

Cemetery, Harris discussed the mowing contract may need to be adjusted—more work and mowing had to be done then originally estimated. Other improvements will also need to be done to the cemetery. Adam Dahlstrom had suggested closing the old part of the cemetery to sales until better records could be found as to what is available; this will be discussed in the future. **Alleys** are

being bladed and areas needing gravel are being marked. **Streets** south of the tracks are being reviewed for drainage improvements; the next phase of the current project includes many improvements to the gravel roads in town. **Mosquito Spraying**, aerial spraying will be scheduled later this week (prior to Evening in the Park).

Moore Engineering:

Kent Ritterman and Jerod Klabunde updated the Council on the current projects.

14th Street Sewer Lift, there is concern the lift station is running too much. They are reviewing the original plan and working with the railroad to make possible improvements.

2009-2 Phase 1 Part C-Main Avenue Improvements, bases are installed and light poles have been ordered. Forward moved, Sitzler second to deny request by First State Bank to not install a light on the property, carried.

Forward moved, Harris second to approve Change Order #2 for \$34,498 for Main Avenue Improvements to Kuechle Underground, carried.

Sitzler moved, Kuipers second to approve Partial Pay Estimate #1 to Kuechle Underground for \$114,650.93 for Main Avenue Improvements, carried.
