Visitors:

Russell Thompson, recently received a letter notifying him he needed to move the semi-trailer parked on his property. He explained he recently had unexpected heart surgery and it was never his intent to leave it there for this length of time. As his condition improves they will be moving items in the trailer and removing it from property. Johnson will stay in touch with them on timeline and progress. **Dennis Bohnenkamp,** was not present to discuss his request to have access to city water connected to a home he owns just outside of city limits. Discussion was held on city ordinances and other properties outside of city limits with water service with no decision being made without more information from Mr. Bohnenkamp.

Committee Reports:

Conklin, has been approached by residents concerned about high water levels along the north side of the railroad tracks near Hockenberry Park. The water is rising into yards and doesn't seem to be draining. Nelson stated he had worked with Dakota Improvement to shoot elevations with laser and they then improved drainage based on findings; will check on culverts for issues but believes the ground water is too high to allow more drainage. Schaefer, received reports that areas of the sidewalk along Highway 1 are raising up causing hazards for pedestrians. Ordinance states that homeowners are responsible for repairs to sidewalks along their property but will check if that sidewalk is part of the walking path possibly shifting responsibility to the city. **Police Department**, is back in the state overtime program and will be applying for funds to cover overtime shifts for underage drinking and seatbelt use. Public Works, Nelson updated the council on the sink hole that formed on the corner of Main & 15th. High ground water made work difficult and General Irrigation was called to dewater. Haring & Nitschke were able to fix the issues with the sewer line and the water line that collapsed when filling the hole. Sewer lines were televised revealing clay time from 14th-16th and Moore Engineering has suggested using a sleeve to fix the problem. Johnson will work with USDA & Moore to find funds for the project. Waste Disposal Site, rates for dumping items were discussed. Nitschke contacted Waste Management to deliver containers to the site as they will take many items for less money than Gahner Sanitation. Working on ideas to access the site that wouldn't involve paying an attendant to be at the site and allow for extended hours. The garbage portfolio will meet to come up with a plan moving forward. Auditor, a property that has been notified to clean up junk items multiple times is still not making any progress. Council agrees to move forward with writing citation to property owner. Disconnects for non-payment were suspended in March and some bills are now \$1000+. These are bills that were well past due in March and are on the disconnect list continually. Harris moved, O'Brien second to start disconnects for non-payment of water bill, carried. Zimmer, updated council on updated quote for emergency sirens. A sound study will be completed to determine the number of sirens that will be required to provide coverage City Wide.

New Business:

Conklin asked about options for replacing trees along Highway 1 that were killed and damaged over the last two winters. He would like the trees replaced or pruned to improve looks.

Harris moved, Bakke second to adjourn the meeting at 7:09 PM.
