## Committee Reports:

Bakke inquired about Phil Hansen signs on each side of town. The signs are out of city limits and on private property, council does not need to approve any changes. **Dangerous Buildings**, Bagley brought to attention a few homes that have fallen into serious disrepair or have suffered damage. Paradis discussed the ordinances for declaring buildings dangerous and the steps that need to be taken. **Bulk Water**, Nelson asked the council to consider increasing the rate for bulk water. Requests for bulk water are coming more frequently and he feels our rate is too low. Schaefer moved, Bagley second to increase rate for bulk water to \$20.00/1,000 gallons, carried. **WTP**, operator position is open Nelson and Nitschke are keeping things running with the help of a few outside individuals. They will reach out to some contacts before advertising for the position.

#### Unfinished Business:

Variance Request, letters were sent to all neighbors within 150' of Jorgenson property. No complaints or concerns were received, Bagley moved, Schaefer second to approve variance for Jorgenson deck permit, carried.

### New Business:

Conklin Memorial, Johnson was contacted about the City partnering with the School and OEI to place a memorial, honoring Art Conklin, on the school grounds. Mayor O'Brien took this time to extend the council's sympathies to Art's family and express gratitude for his years of service to the community.

Tourism Funds Request, Bakke moved, Bagley second to give \$500.00 to the American Legion for the fireworks display, carried. Sales Tax Funds Request, First reading of the request from the Golden Age Club for \$6,000 to help re-shingle the roof at the senior center. Bakke moved, Schaefer second to allocate the funds and provide payment when the project is complete, carried. County Re-Districting Board, Bakke volunteered to be the Oakes representative on the Census Redistricting Board. Vacant Council Positions, two positions are open at this time on the city council. Due to the suddenness of this situation no appointments will be made at this time. Anyone who may be interested in filling a vacancy should contact Auditor Johnson or a council member.
